

GENERAL FEE SCHEDULE

(Effective 9/13/2016)

1. Zoning Ordinance or Zoning Ordinance with Map. The fee to be paid at the time of purchase shall be \$20.00.
2. Zoning Map. The fee to be paid at the time of purchase shall be \$5.00.
3. Subdivision Ordinance. The fee to be paid at the time of purchase shall be \$15.00.
4. Stormwater Management Ordinance. The fee to be paid at the time of purchase shall be \$7.00.
5. Stormwater Management Small Project Design Assistance Manual. The fee to be paid at the time of purchase or with issuance of building permit shall be \$2.50.
6. Stormwater Design Plans:
 - a. Buildings less than 1,000 square feet - exempt.....\$25.00
 - b. Buildings 1,000 square feet but less than 4,000 square feet (small project)
 - Initial application review and two (2) inspections..... \$150.00
 - Additional inspections \$100.00 each
 - Additional Township Engineering fees will apply if that review is deemed necessary.*
 - c. Over 4,000 square feet requires a formal storm water management plan
 - Administration Fee.....\$250.00
 - Plus all Township Engineer review costs.*
7. Copies. The fee for copies of Township records or information to be paid before records are released shall be \$.25 per page per side for standard sized paper copies and \$1.00 for certification of copies. Specialized documents – including but not limited to blue prints – \$5 per page per side. Color copies and non-standard sized documents shall be charged the actual cost of production. If mailing is requested, the cost of postage will be charged. Copy requests must comply with East Earl Township’s Right-to-Know/Open Records Policy.
8. Police Reports. The fee to be paid for a certified copy at the time of issuance shall be \$15.00. Copies must be requested from the Police Department.
9. Misc. Fees.

 - Agricultural.....\$40.00
 - Commercial..... \$150.00
 - Residential New Construction.....\$100.00
 - Alterations/Additions—Existing\$50.00
 - Utility Shed (with no utilities & on skid or platform 100 sq. ft. or greater) \$50.00
 - Fence\$50.00
 - Above or In-Ground Pool.....\$60.00
 - Tent.....\$55.00
 - Demolition Permit.....\$10.00
 - State Training Education Fee (when applicable) \$4.00
 - Zoning Use Permit.....\$65.00
 - Permit Renewal (one year maximum)\$35.00

- Temporary Use & Occupancy (requires a visit to the property) \$65.00
- Signs:
 - Non-Profit.....30 Days..... No Charge
 - Non-Profit.....30 – 90 Days.....\$50.00
 - Temporary90 Days.....\$50.00
 - Permanent.....\$75.00
 - Banner – Temporary30 Days.....\$55.00
- Timber Harvesting Permit \$110.00
- Solar – Commercial..... \$150.00
- Solar – Farm/Residential.....\$75.00
